

# West Academic Early eBook Access

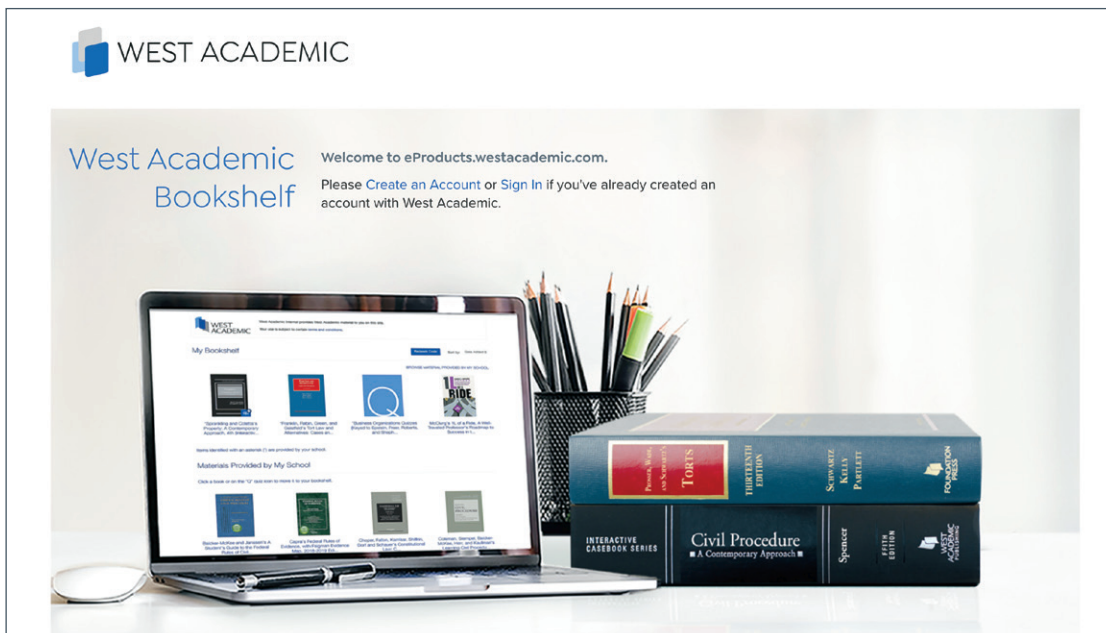
## INSTRUCTIONS

Your law school has partnered with West Academic to provide free, temporary eBook access to all the West Academic and Foundation Press® casebooks required for your classes. Your free eBook access begins the week before classes start through the first two weeks of the semester. Follow the instructions below to set up early eBook access and learn how to purchase a discounted eBook for access beyond that period.

### How to start your free trial:

Go to [eproducts.westacademic.com](http://eproducts.westacademic.com) and click “Sign In” in the right corner of the screen. If you do not have a West Academic account, click “Create an Account” from the Sign In page. Be sure to use your law school email address when creating an account.



If you created a new account, you will receive a verification link in the inbox of the email address you used to sign up. Before you get started, you'll need to verify your account by clicking the link in the email you've received.





